INTRODUCTION

This report summarizes an assessment of scholarships awarded to College of Forestry (COF) students and how they are distributed among various student cohorts. The assessment is primarily concerned with identifying student cohorts that receive a disproportionately lower share of scholarship resources relative to their overall representation of the COF student population. The outcomes of this assessment will inform how COF allocates its scholarships and whether any type of redeployment of its scholarship resources is needed. This work directly addresses an informational need within Oregon State University's (OSU) Student Success Initiative (SSI).

SSI is a collaborative effort between OSU, Colleges, and the OSU Foundation with the goals of

- Increasing financial accessibility to all students
- Recruiting high achieving students
- Promoting and supporting experiential learning for all students.

The Colleges were asked to

- Set priorities among the three goals
- Assess redeployment of existing scholarship funds to meet priorities
- Establish fundraising strategies to meet priorities with OSU Foundation.

The assessment primarily addresses the first two goals given the majority of scholarship resources in COF are provided as financial support. Experiential learning scholarships are included in this assessment, but they are not differentiated in this assessment. COF does support students' experiential learning through various means, including scholarships, program support, student hourly positions, volunteer opportunities, and required work experiences. A formal evaluation of experiential learning access and participation by student cohort is not possible until they are consistently and completely documented.

DATA

Enrolled student data for COF were provided by OSU Admissions Office and covered the past four academic years (2012/13, 2013/14, 2014/15, 2015/16). Data were pulled to identify a variety of cohorts as listed below. These cohorts are not mutually exclusive when comparing

across all cohorts; however, they are mutually exclusive within some cohort categories (e.g., fulltime/parttime, resident/nonresident, freshman/transfer, and female/male).

- Campus (Cascades, Corvallis, Ecampus, LaGrande)
- Major (all)
- Fulltime/Parttime (enrollment status)
- Freshman/Transfer (student type code)
- 1st Generation (self-reported)
- Resident/Nonresident (admit rate code)
- Veteran (veteran type)
- Female/Male (gender – does not include “not designated”)
- Underrepresented minority (URM) by race (aggregation of self-reported race codes including American Indian or Alaska Native, Asian, Black or African American, Hispanic, Multiple, Native Hawaiian or Pacific Islander)
- Pell Eligibility (financial aid designation)
- Cumulative OSU GPA – sorted into four mutually exclusive categories.

In addition, the total number and amount of scholarships received as recorded in the student database. These scholarship data were then summed as total scholarships (regardless of source) and COF scholarships, enabling evaluation of the overall distributions as well as COF distributions.

CAVEATS

These data represent student status at a point in time and may not reflect changes in enrollment status or major migration patterns throughout an academic year. Sorting of scholarship types into the COF bin was based on judgment. Scholarship data includes those funds provided for experiential learning, although this amount is minor relative to general student financial support scholarships.

This assessment does not address any strategic recruitment goals for any of the cohorts identified—it is evaluating the distribution of scholarships among the existing size of each cohort.

SUMMARY OF OVERALL DATA AND FOCUS OF ASSESSMENT

A breakout of the data is provided in a series of tables in Appendix B. These tables report

- The number of students
- Number of students receiving scholarships
- Total scholarship funds
- Percentage of student counts to college total counts
- Percentage of scholarship funds allocated to a cohort of the total scholarship funds
- Average scholarship award amount.

These statistics are reported for

- All scholarships awarded
- COF scholarships awarded
- Enrollment status (fulltime, parttime, and total)
- College
- Campus
- Major
- Natural Resources majors by campus.

The majority of scholarships provided to students are restricted to fulltime students, and the majority of COF scholarships are donor-restricted to majors only available on the Corvallis Campus. A perusal of the Appendix B tables illustrates these points. The final assessments of scholarship distributions are, therefore, limited to the College in total and the Corvallis Campus.

SCHOLARSHIP ALLOCATION DATA

Appendix A provides tabular information for the data used in assessing the distribution of scholarships among cohorts in COF—these tables simply compile data relevant to the assessment from Appendix B. These data consist of proportions and average awards for the College (Tables A1-A4) and for the Corvallis Campus (Tables A5-A8). The College data includes all undergraduate students enrolled in the College; whereas, the Corvallis Campus only includes fulltime students.

The Appendix A tables also include color-coding to identify how ratios were calculated. The darker toned cells comprise the denominator and the lighter toned cells comprise the numerator for each ratio. These ratios are a simple representation of how scholarships and scholarship dollars are distributed among cohorts. For example, the denominator represents the College proportion of students receiving a scholarship from among all students in the College. The numerator represents the proportion of students within a cohort receiving a scholarship among the students in that cohort. If scholarships are randomly assigned, then the ratio should be equal to 1. Ratios <1 represent cohorts that proportionally receive fewer scholarships relative to the college rate, and ratios >1 represent cohorts that proportionally receive more scholarships relative to the college rate. However, scholarships are not assigned randomly by OSU or COF. Some scholarships target high achievers as defined by scholastic achievements, some are merit-based as defined by cumulative OSU GPA, and other scholarships target other types of cohorts. Therefore, we would expect high achievers to be disproportionately represented and receive awards.

COF scholarships are primarily awarded based on merit. The primary question we are interested in answering is how COF scholarships are distributed among cohorts when they are driven by merit (i.e., cum OSU GPA). COF awards about \$500,000 in scholarship funds to its undergraduate students each year, primarily supporting Corvallis Campus majors. Of the approximately 36% and 20% of COF Corvallis Campus fulltime majors receiving any source of scholarship and COF scholarship, respectively, are they representative of the various cohorts of interest?

RESULTS

Relative Allocations of Scholarships




Figure 1. Distributions of All (OSU + COF) scholarships at the College level.




Figure 2. Distributions of COF scholarships at the College level.




Figure 3. Distributions of All (OSU + COF) scholarships at the Corvallis Campus level.




Figure 4. Distributions of COF scholarships at the Corvallis Campus level.




Figure 5. Distributions of total scholarship dollars at the College level.




Figure 6. Distributions of COF scholarship dollars at the College level.




Figure 7. Distributions of total scholarship dollars at the Corvallis Campus level.




Figure 8. Distributions of COF scholarship dollars at the Corvallis Campus level.

Scholarship Average Awards Comparisons




Figure 9. Average Total Scholarship Award Amount (\$), College.

Figures 9-12 compare cohort average scholarship awards (total and COF) for all students in the College and Corvallis Campus fulltime students across the past four academic years. The baseline average scholarship award is calculated as the 4-year average scholarship award based on the scholarship source and scope of assessment (i.e., College vs. Corvallis Campus).

A visual comparison of Figures 9-12 result in the following key outcomes.

- Average awards for total scholarships show:
 - Cohorts that receive average awards higher than the baseline include
 - High Achievers
 - URM-Race
 - Cohorts that receive average awards lower than the baseline include
 - Low Achievers
 - Veterans
 - 1st Generation (not always)
- Average awards for COF scholarships show:
 - Cohorts that receive average awards higher than the baseline include
 - High Achievers
 - Cohorts that receive average awards lower than the baseline include
 - Low Achievers
 - Veterans
 - 1st Generation (not always)
 - Nonresidents (not always)




Figure 10. Average COF Scholarship Award Amount (\$), College.




Figure 11. Average Total Scholarship Award Amount (\$), Corvallis Campus.




Figure 12. Average COF Scholarship Award Amount (\$), Corvallis Campus.

DISCUSSION

The current disbursement of College of Forestry scholarships primarily follows a merit-based strategy. The primary disbursement restriction on COF scholarships is fulltime students in good standing; donor-preferences primarily restrict funds to specific majors or geographic locations, when these preferences exist. The greatest concern would be for those cohorts that received disproportionately lower shares of scholarships and funds.

One cohort receiving a disproportionately lower share of scholarships and funds is Low Achievers (cum OSU GPA < 3.0). However, this is a direct outcome from the disbursement strategy of merit-based allocations. Conversely, High Achievers (cum OSU GPA > 3.75) receive a disproportionately higher share of scholarships and funds. This outcome is not a direct concern for re-deploying scholarship funds to this cohort insofar as this cohort is not strongly correlated with another cohort.

The other cohort that does raise concern is Veterans. The Veteran Cohort systematically aligns with disproportionately lower shares of both the number of scholarships and the amount of scholarship funds. COF had, on average, 74 Veterans per year (includes all classifications for Veteran status at OSU) over the past 4-years; 52% of them Fulltime. Further, over 20% of fulltime Veterans have cum OSU GPAs >3.5, and an additional 30% with cum OSU GPAs > 3.0. Based on the primary targets of Fulltime and merit-based, Veterans should be receiving scholarships and amounts greater than what they received over the past 4-years.

CONCLUSIONS / NEXT STEPS

Given the sheer volume of scholarship funds managed by the College of Forestry each year relative to the number of eligible students, this assessment generally finds the various cohorts of student types well-represented scholarship disbursements (the exception being Veterans as discussed below). Therefore, an outcome of this assessment is that the College of Forestry does not need to redeploy its scholarships—its current deployment of scholarships is perfectly in alignment with the goals of the Student Success Initiative. Instead, the College of Forestry will focus on recruiting, expanding experiential learning programs and access, and increasing the amount and types of funds supporting student success. These intersect well with OSU Foundation's strategic initiatives regarding the Student Success Initiative.

Veterans – get the word out! We will work with the Military and Veteran Resources in the Office of Student Life, as well as with our own communications office, to increase Veteran's awareness of our scholarship opportunities available to them, and to encourage Veterans to submit scholarship applications.
