RE: A Bugs Life Harvest Exemption

This memo is written in response to the proposed timber harvest named "A Bugs Life" which requires an exemption from the 2005 Forest Plan. An exemption has been requested for this 7.5 acre sanitation and restoration harvest to be conducted in the Oak Creek Drainage off Road 770. On a dry ridgetop where drought had greatly reduced the vigor and induced mortality among the conifer trees. This 52 – 60 year old stand now has a number of dead and insect infested conifers and a few remaining oaks. The minimum regeneration age for this stand according to the forest plan is 70 years. Therefore an exemption was requested to harvest predominantly dead and dying trees that are younger than 70 years.

In accordance with the Plan, Brent Klumph presented a proposed exemption to the forest plan to the Forest Executive Committee with four options: 1) No action; 2) Age exemption with just hazard tree removal; 3) Age exemtion for four acres; 4) Age and size of stand exemption to harvest 7.5 acres with structural and visual retention (preferred option).

After a brief discussion regarding ecological considerations and justification, the Committee expressed their general support for the prererred option. Retention of the remaining oaks and the few healthy, large Douglas-fir was emphasized in an effort to move the stand to a more open savannah like stand with a combination of oak and Douglas-fr.
